Adolescent Reproductive and Sexual Health (ARSH) Services

Integrated Health & Family welfare society, PCMC (RCH Society) is implementing RCH-II project under four technical strategies. One of these is Adolescent Health Strategy ARSH has been approved as part of the RCH-II -PIP. This strategy focuses on recognizing the existing ARSH clinics in PCMC Hospitals in order to meet the health service needs of adolescents.

PCMC has adopted this strategy and started ARSH clinics in 4 hospitals where clinics are held once a week on fixed days. Viz Yamunanagar, Bhosari, Jijamata, Talera Hospital zones.

PCMC invites proposal form Health/Research Agencies or NGOs, to undertake activities to strengthen ARSH services at facility and community level as follows

1. Outreach activities for ARSH clinics.

To conduct lectures followed by Essay /Quiz/ poster competitions in 10 educational institutions per ARSH clinic jurisdiction @ Rs 2000/- per educational institution

2. Promotional activities for ARSH clinics

To promote utilization of ARSH clinic by providing value added services to adolescent girls and boys. Organizing Diagnostic camps which includes HB testing, blood grouping. Arrange visit to ARSH clinic.- for 2000 students per ARSH clinic jurisdiction @ Rs 50/- per student
