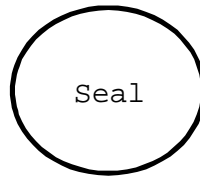

(Spot Fine Under SWM Rules-2016)

All citizens are hereby informed that Ministry of Environment, Forest and Climate Change, Government of India has notified and enacted Solid Waste Management Rules, 2016 vide Notification No S.O.1357(e) dated 08.04.2016. These rules are effectively being implemented in the city. In accordance with Government Resolution No: SMA-2017/C.R.256/UD-34 Urban Development Department, Government of Maharashtra Dated 30th December 2017, ULBs are authorized to levy spot fine in all cases be it citizens/ Organizations where provisions of Solid Waste Management are Violated.

Accordingly, the penalties mentioned below will be levied on all those violating the said SWM Rules 2016.

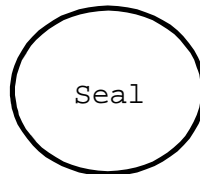

(Regarding Solid Waste Management)

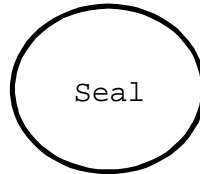
Solid Waste Management Rules 2016 have come into effect as per Ministry of Environment, Forest & Climate Change, Government of India. Notification No S.O.1357 (e) dated 08.04.2016. In accordance with the provisions under these rules, it is responsibility of every Waste Generator to segregate waste into degradable (wet), non-degradable (dry) and household hazardous waste, and hand over this segregated waste to the persons/agency appointed by the ULB in this regard. These SWM Rules 2016 are thereby being implemented in the jurisdiction of this Urban Local Body.

All citizens are hereby informed to comply with Solid Waste Management Rules 2016. Anybody found violating the provisions of the rules, will be liable for penal action in accordance with the provisions under the said rules.
