# <u>Draft - Graded Response Action Plan (GRAP) for Pimpri Chinchwad</u>

### <For Public Consultation>

(24th November 2023)

- 1. The GRAP for PCMC has been classified into four phases; Phase 1 "Moderate to Poor", Phase 2 "Very Poor", Phase 3 "Severe" and Phase 4 "Severe+ or Emergency".
- 2. Actions specified under each phase shall be invoked based on the prevalent AQI and the forecast AQI levels for the next day as per the SAFAR app and based on any forecast from IITM or MPCB.
- 3. Actions under previous phases shall be continued in addition to the actions under the phase that is envisaged to be invoked. For example, when restrictive actions under Phase 3 are invoked, it shall be in addition to the actions under Phase 1 and Phase 2.
- 4. The Task Force at PCMC for Air Pollution shall meet in advance and take necessary actions in consultation with experts and issue necessary orders for invoking the GRAP phases. The Task Force shall take all steps towards effective implementation of the GRAP.
- 5. The Task Force may decide to revise the GRAP or add any additional measures, make improvements and exceptions to the GRAP schedule as per the prevalent situation and AQI levels.
- 6. All the penalties levied for violations shall be as per the Annexure

#### Phase 1: "Moderate" to "Poor"

Moderate - When PM2.5 is between 61-90 μg/m3 or PM10 is between 101-250 μg/m3; Poor - When PM2.5 levels are between 91-120 μg/m3 or PM10 levels are between 251-350 μg/m3

Phase 4: "Severe+ or Emergency"

Introduce vehicle restraint measures or introduce low-emission zones in the city to stop entry of polluting vehicles (Below BS-VI, old and polluting diesel vehicles etc.). A system to identify fuel type and age of the vehicle using specific indicators on the vehicle may be used as per MoRTH guidelines. All the vehicles and the Inspection and Certification centres in the city need to adhere strictly to the Central Motor Vehicle Rules. The implementation and enforcement of the same shall be done by RTO and the Traffic Police.


